Item #5 TO HEAR THE PETITION OF DOUGLAS & ELIZABETH KRUSE TO REQUEST A VARIANCE TO BUILD AN ACCESSORY BUILDING WITHIN THE 70 FEET FROM THE CENTERLINE OF A TOWN ROAD AND BE LARGER THAN 70% OF THE FLOOR SPACE OF THE RESIDENCE IN SECTION 24 OF HENRIETTA TOWNSHIP Douglas is present to represent the petition. His parcel is zoned Residential which limits his building to 70% of the primary residence of the floor space. Also his parcel is steep so he cannot meet the 70' set back. The Township approved. Moved by Tom to approve the variance to the 70% rule and the road setback, 2nd by Randy. Motion carried
