Item #3 <u>APPROVE MINUTES OF THE FEBRUARY 5 MEETING</u> Hearing no changes to the minutes Larry ask they be approved as mailed.

Item #4 TO HEAR A PETITION OF JIM, TOM & ROBERT BAILEY AND KENT ADSIT TO REZONE 16 ACRES FROM AGRICULTURAL-FORESTRY TO AGRICULTURAL-RESIDENTIAL IN SECTION 29 TOWN OF DAYTON Kent Adsit is present and stated he has an approved offer on the Bailey property. He would like to sell the house and buildings with 15 acres to his Dad. Mike explained the Township minutes reflected only the smaller parcel rezone. Moved Jim to approve the rezone and send to County Board on March 20th, 2nd by Melissa. Motion carried

Item #6 OFFICE REPORT Mike handed out copies of Act 67 and 68. These have to do with substandard buildings. The Acts are trying to eliminate putting conditions on Conditional Use permits. These acts also put the burden on the Counties to prove why the Conditional Use should be denied and that Conditional Use Permits cannot be denied if significant reasons are not proven. The District will be meeting on March 15th to discuss it further.
